## DONATIONS POLICY

**Effective Date:** 11 July 2026

**Atlantic Eye Foundation** ("we", "our", or "us")

To strengthen South Africa's ophthalmology workforce and expand access to quality eye care through training, service delivery, and research. This Donations Policy explains how we manage contributions made through our website and other channels.

### 1. Purpose of Donations

All donations received by the Atlantic Eye Foundation are used to support:

- Ongoing and future medical research projects
- Training and education of Registrars, Medical Officers and Interns
- Community outreach initiatives
- Operational expenses necessary to sustain our research and outreach

We are a nonprofit organization. Donations are used responsibly and in accordance with our mission and public benefit activities set forth in our capacity as a PBO.

### 2. Tax-Deductible Contributions

The Atlantic Eye Foundation is a Section 18A Public Benefit Organisation. Donations may be tax-deductible to the extent permitted by law. Donors are encouraged to consult with a tax advisor for guidance on deductibility.

### 3. Donation Methods

We accept donations via:

- Bank transfer (available upon request)
- Other methods as detailed on our website

We do not store full credit card or banking details on our servers. All payment processing is handled by secure, PCI-compliant providers (e.g. SnapScan)

#### **4. Recurring Donations**

If you choose to make a recurring donation:

- Your payment method will be charged automatically at the frequency you select.
- You may cancel or modify your recurring donation at any time by contacting us or accessing your donor account (if available).

#### **5. Refund Policy**

Donations are generally non-refundable. However, if a donation was made in error, please contact us within 14 days of the transaction. We will review requests on a case-by-case basis and may issue a refund at our discretion.

We are committed to respecting your privacy. Donor information is used only for:

- Processing and acknowledging donations
- Issuing tax receipts

We may publicly acknowledge donors (e.g., on our website or reports), unless the donor chooses to remain anonymous. To opt out of public recognition, contact us directly or select the anonymity option when donating.

#### **8. Use of Funds**

While donors may indicate preferences for how funds should be used (e.g., toward a specific research area), we reserve the right to allocate donations in the manner that best supports our strategic objectives and public benefit activities, unless otherwise agreed upon.

#### **9. Transparency and Disclosure**

The Foundation shall maintain records of all fundraising compensation arrangements and may disclose such arrangements where required by law, governance obligations, donor requirements, or considerations of transparency and good faith.
